



## One Year Warranty

Your watch is warranted to the owner for a period of one year from original date of purchase against defects in materials and workmanship. (Do not return watch to your dealer). The warranty does not apply to case, crystal, strap, bracelet or batteries. The Case and Bracelet is sold as is. Case and bracelets are not gold plated and may tarnish, also stones may fall out. This warranty is extended in compliance with standards set forth in the "Magnuson-Moss Warranty Federal Trade Commission Improvement Act". Liability is limited solely to the repair of the watch. We disclaim liability for consequential damages for breach of any expressed or implied warranty including merchantability or fitness for purpose.

If this watch develops such defects within this period, it will be repaired or replaced ( a watch of equal value and similar appearance will be supplied) at our option-provided it is returned with a \$7.50 USD money order to cover cost of postage and handling. No additional charge will be made unless the one year warranty period has expired or servicing not performed by us.

The above remedy is exclusive and company shall NOT be liable for any incidental or consequential damages. This warranty is void if the watch has been tampered with, damaged by water, or ill-treated, or if the defect is related to servicing not performed by us.

1. WRAP SECURELY- Do not use original gift box as it cannot be returned. Do not mail in a plain or padded envelope.
2. ENCLOSE THE COMPLETED WARRANTY - This paper must be included inside the package with your watch. Mailing boxes are unpacked, so return addresses in the box is not available to identify ownership.
3. INCLUDE A MONEY ORDER FOR \$6.50 to cover shipping & handling and insurance. (THIS IS NOT A REPAIR CHARGE).
